

Niko Receives Conversion Notice

CALGARY, ALBERTA (May 2, 2014) – Niko Resources Ltd. (TSX – “NKO”) announces that on May 2, 2014, it received a notice of conversion in accordance with the terms of the amended and restated 7% senior unsecured notes due July 13, 2014 (the “Notes”) to convert approximately US\$0.6 million of the Notes. The conversions will result in the issuance of 350,000 common shares to a holder of the Notes and the outstanding principal balance of the Notes will be approximately US\$3.8 million.
