

Niko Receives Conversion Notice

CALGARY, ALBERTA (June 18, 2014) – Niko Resources Ltd. (TSX – “NKO”) announces that on June 18, 2014, it received a notice of conversion in accordance with the terms of the amended and restated 7% senior unsecured notes due July 13, 2014 (the “Notes”) to convert approximately US\$0.1 million of the Notes. The conversion will result in the issuance of 61,837 common shares to a holder of the Notes and the outstanding principal balance of the Notes will be approximately US\$0.6 million.
